Do The Laboratory Tests Request as Chemotherapy Control Really Reflect That the Patient Can Continue Chemotherapy?

Editorial

In our world, everything around us is made up of a complex of atoms [1]. Human beings are also composed of atoms, and this generates energy until it transforms into the matter which we can visualize with our naked eyes. There is a part of matter that has not materialized yet (that is the energy) that exists in all things in our universe, including humans [1]. In the book written by Capra [1], whose title is Tao of Physics, he talks about the different points of view of Western medicine and traditional Chinese medicine, and the integration of the two medicines is necessary for us to understand whether the laboratory tests requested by oncologists to see if the patient may or may not continue chemotherapy reflect that the patient is really well to continue his treatment [1-3]. According to the progression of health to the disease, we can divide into five phases, and in the first three phases, the patient has symptoms, but laboratory tests are normal. In these first three phases, the patient has energy alterations that have not yet materialized in a laboratory change. However, if we measure the energy of the five massive internal organs of the five elements theory of traditional Chinese medicine, using the radiesthesia procedure, we will see that all these organs are without energy, as I demonstrated in a study analyzing the energy of the five organs (Liver, Heart, Spleen, Lung, Kidney) of 1000 patients during 2015 to 2020 and concludes that 90% of these patients analyzed were without energy. However, if I do this same study today in 2023, I would say that 100% of patients today are without energy in these organs, which are important for the production of internal energy to maintain our life health. The lack of these energies causes a state of internal immunosuppression, making the individual more prone to having any emotional or physical illness, especially cancer in its final phase, in phase 5 [2, 4-9]. Therefore, patients who are in normal exams do not reflect the energy alterations that these cancer patients present. In the article, I wrote (2020) titled The Importance of Treating Energy Imbalances and Chakras Replenishment for Prevention and Treatment of Cancer, I am saying that cancer according to traditional Chinese medicine is caused by a lack of internal energy and internal Heat formation [2, 3]. The lack of energy that all cancer patients have meant that the use of highly concentrated drugs should be less used because they can cause even more the loss of the patient's vital energy and cause more harmful effects to the patients because this same energy is responsible for the process of the patient's body to defend itself against the production of malignant cells, which occur daily in our body, eliminating them [2, 10].

Therefore, the laboratory tests carried out to verify that the patient with cancer can continue with his therapy, do not reflect what the patient really has, because what he has at the energy level, which does not appear in the tests, is a complete lack of vital energy. The cancer patient in this situation is not able to continue to use another load of medication that will further reduce their energy, which is already low, to continue their "treatment protocol". I attended to a patient this week (January 2023), who is undergoing treatment for breast cancer, which she acquired 7 days after having taken the third dose of the COVID-19 vaccine. She is undergoing



chemotherapy treatment, but she is experiencing very strong dizziness, lack of appetite, and extreme fatigue. She also cannot lie down to do her acupuncture sessions, needing to sit down to get the acupuncture needles. Her exams were normal, and her oncologist would probably tell her to continue the treatment, but her internal energies were depleted, as was reported in the recent article written by myself (2023) whose title is Which Could Be the Risks Factors for Developing Cancer After Receiving The COVID-19 Vaccine? [3,11]. In another article written by me (2022) whose title is *Energy* Alterations in Patients with Dizziness and How Can We Treat This Condition Without Using Common Medications? I am demonstrating that behind a patient with dizziness, there are deficiencies in the energy of the five massive internal organs of traditional Chinese medicine, and therefore, giving chemotherapy to a patient with low energy can increase the risk of a patient having complications, such as myocardial infarction, thrombosis, etc. or the formation of new cancer or metastases, because what protects the patient from having another cancer is not using chemotherapy but rather increasing the vital energy, which is lowered and which is causing the formation of diseases, including cancer in its final stage [2, 9, 12]. The treatment of this lack of vital energy in all cancer patients can make the patient more energized to withstand the adverse effects of chemotherapy, as it reduces the vital energy, according to the theory of Arndt-Schultz Law, created in 1888 by two German researchers [2, 13]. In this law, the two German scientists emphasize the need to use highly diluted drugs in order to increase the vital energy, which is lowered in all cancer patients, and the use of highly concentrated drugs must be reduced or abolished, in order to have an increase of this energy, which is lowered in these patients [2, 10].

In a study written by me (2022) whose title was Can The Use of Chemotherapy Induce More Formation of Metastases in Patients with Cancer? I am reporting the case of a medical doctor that lived in the USA and was diagnosed with large intestine cancer. He underwent surgery to remove cancer and after the surgery, underwent chemotherapy for a period. The doctor did chemotherapy for 6 months and after this period, he had metastases in both lungs, which he did not have at the beginning of his cancer diagnosis [13]. For this reason, the treatment of energy deficiencies is of paramount importance in the treatment of these patients, as in addition to treating the cause of cancer formation, it will support the use of chemotherapy, which as I said, would be causing a greater drop in energy, causing many complications in patients such as hair loss, symptoms of depression, anxiety, fatigue, weakness, etc [13]. The use of chemotherapy alone, without the combined treatment to increase the energy of the five organs of patients, can cause serious side effects similar to depressive symptoms, but actually caused by an energy deficiency and not by neurotransmitter deficiency [4, 13]. The use of chemotherapy without the associated use of highly diluted medications to increase the energy of the five massive internal organs can even cause the death of the patient who is using this type of medication (chemotherapy) because for life we need energy and if we use highly concentrated medications to treat this patient, he will inevitably have complications or even death [10, 13]. Therefore, when I hear that such a person died of cancer, it makes me think that the patient died from the cancer treatment he received and not the cancer itself [10, 13]. I say this because, since the time of Hippocrates (460 BCE - 375 BCE), the father of medicine, he says that when a patient has cancer, the best thing would be to leave him without treatment because the treatment would lead to a major drop in energy, which is no longer good and could lead to patient's death [14]. The treatment of only the energy imbalances of the "roots" of the tree can also treat cancer without the need to carry out a treatment at the "leaf" level of the tree because what is weak is the "root" of the tree, which led to the formation of cancer at the "leaf" level of the tree. Tree [2, 9].

In 2018, I treated a 40 years-old female patient with a history of pap smear alterations grade IV. She went to my clinic, and I measured the energy of her internal five massive organs (Liver, Heart, Spleen, Lungs, and Kidney) of the five elements theory of traditional Chinese medicine. All her internal massive organs' energy was without energy, rated one out of eight. I treated her condition by rebalancing the internal energy using Chinese dietary counseling, and auricular acupuncture with apex ear bloodletting. It was also used the replenishing these organs' energy using highly diluted medications according to the theory of Constitutional Homeopathy of the Five Elements based on Traditional Chinese Medicine and crystal-based medications. The patient improved her condition by normalizing the pap exam after one month of treatment using all these tools and without using any kind of highly concentrated medications [15]. In my clinical practice, I have patients with cancer that was cured without using any chemotherapy, radiotherapy, or surgery. In the article written by me (2022) titled Energy Alterations in Patients with Malignant Thyroid Tumor and How Can We Treat It without Doing Surgery, Chemotherapy or Radiotherapy, a 70 years-old female patient cured her malignant thyroid tumor only rebalancing the internal energy using Chinese medicines' tools such as Chinese dietary counseling, auricular acupuncture with apex ear bloodletting and systemic acupuncture. Also, it was used highly diluted medications to replenish the energy of the five internal massive organs according to the theory of Constitutional Homeopathy of the Five Elements based on Traditional Chinese Medicine and crystal-based medications [16]. To finalize this article, as said by Hippocrates (460 BCE - 375 BCE), "we need to treat the patients and not the diseases the patient has". Another quote that I usually say in all my conference presentations is "We need to treat the "root" and not just the "leaf" level of the tree" [2, 14]. By treating the "root", we can treat all the patient's conditions at the same time, even if the doctor does not know that the patients have such symptoms. This theory was presented by me at an Acupuncture Research Conference that was held at Harvard Medical School in 2015 [2, 17].
